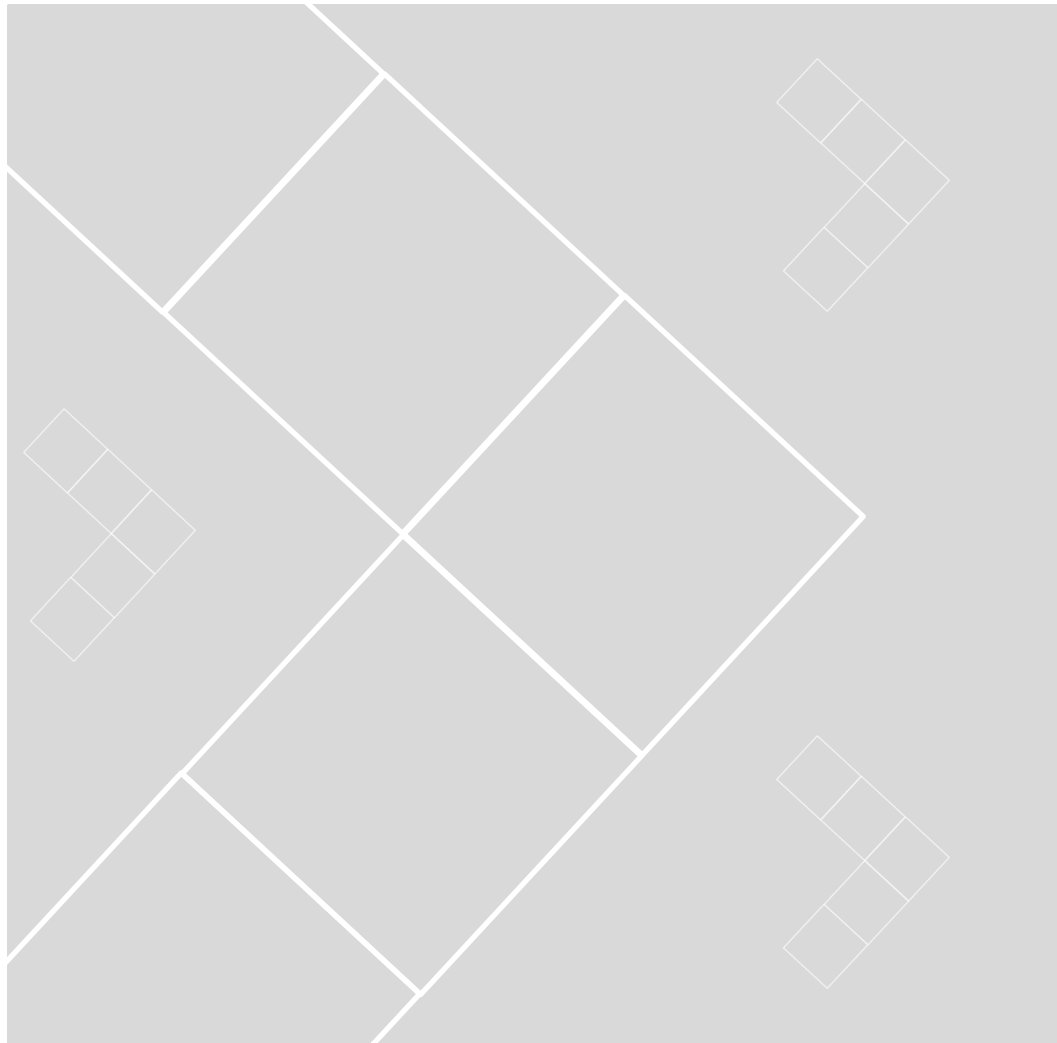




Executive Business Management Programme

Programme Objective

To equip experienced professionals with a holistic, cross-functional exposure to all aspects of management, and the essential thought process and skills required to assume leadership positions in the future within the organisation.



Programme Structure and Duration

- One year, weekend programme starting in July every year.
- Lectures on 2nd and 4th weekends (Saturday and Sunday – every fortnight), effectively totalling to 48 training days and 300 teaching hours.
